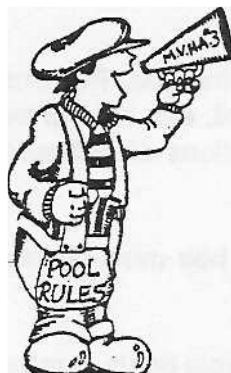


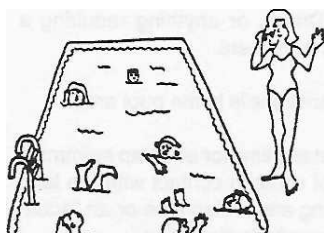
MESA VIEW HOMEOWNERS' ASSOC. #3

POOL RULES



This pool and park belong to you, the homeowner. You are 1 of 349 homeowners who have the right and responsibility to help maintain a good appearance and to help with any behavior problems. Report all incidents to the monitor or a Board member.

1. Only members of M.V.H.A. #3 and their invited guests may use the pool. **Homeowners with delinquent dues may not use pool.**
2. State Health Code (*Title 17, Section 7830*) requires that all persons "afflicted with an infectious disease, suffering from a cough, cold, or sores, or wearing bands or bandages shall be excluded from all public bathing places."
3. **THERE IS NO LIFEGUARD ON DUTY!** Monitors are **not** lifeguards. Their purpose is to enforce pool rules. Use of the pool is at the user's own risk.
4. Pool monitors have control of the pool at all times. Persons abusing pool rules will be asked to leave the pool area. **Monitors have the authority to confiscate pool keys from repeat offenders.** The continued abuse of pool rules will be cause for action by the Board of Directors and could result in a 30 day suspension of pool use.
5. Homeowners assume full responsibility for the actions of their children and guests. **There must be one adult present for every 3 children, age 14 or under.**
6. AGE RESTRICTIONS for Homeowners' children:



0-14: Should not be in pool area unless **supervised** by an adult (*State Health Code: Title 22, Section 6-5539*). In this case only, a 16 year old will be accepted as an adult (with proper ID).

10-14: May be allowed in the pool area without an adult **only when a pool monitor is on duty.**

- May have only one (1) guest who is 10 years or older.
- Must all be able to pass a swimming test conducted by the monitor

15 & older:

- May be allowed in the pool area without an adult or monitor.
- May have no more than two (2) guests Must remain with their guests at all times

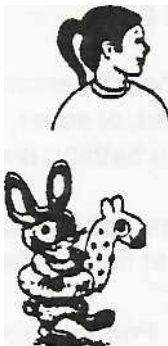
7. Only clean, appropriate swim wear will be allowed in the pool. Clothing worn for street wear and "cut-offs" with ragged or un-hemmed edges is strictly prohibited in the pool.



8. **ALL** children 3 years old and under must wear rubber pants over their pants or diapers. All diapers (cloth or disposable) must be covered with rubber pants when in either pool. **Diapers must be worn at all times in the pool area.**

9. **ALL SWIMMERS MUST SHOWER** each time they enter the pool. Persons using foreign substances, such as suntan lotions, hair oil, etc. will not be allowed in the pool. Exception: waterproof, sunscreen lotions do not have to be washed off.

10. No hairpins, barrettes, etc. in the pool. Shoulder length hair must be tied back.



11. Surfmats, surfboards, Boogie boards, tubes, floats, inflatable boats or rafts, fins, face masks, snorkels, balls, styrofoam of any type, metal objects, etc. will **NOT** be permitted in the pool, **except at the monitor's discretion.** No black fins are allowed at any time. Children's pool toys may be used in the wading pool. (Eye goggles, regulation life jackets and wet suits are allowed).

12. **Diving is permitted in the deep end only, but no back dives are allowed.**

13. Destruction of, or playing with, any pool equipment or safety equipment is prohibited.

14. No running, pushing, dunking, horseplay or **loud or profane language** is allowed in or around the pool area. Radios must be kept at a low volume.

15. **NO** skateboards, bicycles, roller-skates, roller-blades, etc. within the pool fence.

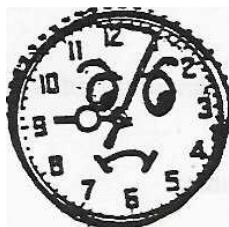
16. No animals of any type will be allowed in the pool area at any time.



17. No glass of any type in the pool area. Drinks, or anything requiring a container, must be kept in metal or plastic containers.

18. No chewing gum, sunflower seeds, or peanut shells in the pool area.

19. Adults may request a lap lane be installed at any time for adult lap swimming only. All other non-lap swimmers must not come in contact with the lane divider or enter into the restricted swimming area. A lap lane or an "adult-swim-only" period may be initiated at the monitor's discretion.



20. Normal operating hours for the pool are **10 AM TO 9:00 PM DAILY**

No one is allowed in the pool area after 9:00 pm or **ANY TIME** the gate is dead bolted. Exceptions may be authorized by the Board of Directors, upon written request.
