#### **POOL KEYS**

If you have lost your pool key, call 858-566-3622 to make an appointment for another key. Please be prepared to leave your name, address and phone number. Your membership will be verified and your call usually returned within 48 hours. There is a \$5 deposit for the 1<sup>st</sup> key to new homeowners. Each key after that will cost \$20 to replace.

**We need a TREASURER:** someone who is computer & financially literate, communicates & works well with others; works closely with our Bookkeeper.

#### THIS SUMMER AT THE POOL

- NO ALCOHOL ALLOWED IN GATED POOL AREA
- Monitors will generally be on duty daily between the hours of I-7 pm in July and I-8 pm in August and September, weather permitting.
- Monitors have control of the pool at all times. Persons abusing the rules will be asked to leave the pool area.
- Monitors have the authority to confiscate pool keys from repeat offenders.
- Children 10 and under must be accompanied by an adult, ages 11-14 may be at pool without an adult ONLY when monitors are on duty, and teens 15 and older may visit the pool without an adult or monitor present.

10:00 am—9:00 pm daily

NO ONE IS ALLOWED IN THE POOL AREA AFTER 9:00 PM!

**Sept 1<sup>st\*</sup>** Delinquent: Late Fee, plus interest on unpaid balance now due

Sept 15<sup>th</sup> Turning over to attorney to issue lien

\* 12% annual (1% monthly) interest on unpaid balance will accrue beginning Sept 1<sup>st</sup> if bill remains unpaid
